Annexure-"B"

SCOPE OF WORK AND WORKS SPECIFICATIONS

- 1. The vendor/ bidder should have reasonable experience in providing services of customized vans with drivers (advertisement/publicity vans, Demonstration vans, cash vans etc.
- 2. GST registration would be essential. The rates will be taken without GST and GST will be charged extra at applicable rates (i.e. Rates + GST). In case the quotation is silent on GST, it will be assumed that the rates are without GST and GST will be applicable over it.
- 3. The tenure of contract will be one/two year which may be renewed for further one year on the same term and conditions if both the parties are mutually agreeable to it.
- 4. Economically, it will be viable to get all the vans operated by single operator/ service provider for all the 20 districts of our Bank. As such, quotation have been invited to operator all the 05 vans.
- 5. Driver cum Caretaker will be provided by the vender/service provider who shall remain on the payroll of the service provider. It will be the responsibility of the Service Operator/ vendor to comply with the rules and regulations of the labour laws and or any other related laws in the matter.
- 6. Bank Authorities will decide about the working days and working hours and operating areas at their own discretion and the service provider will have no objection/ say in the matter.
- 7. Service provider will be required to provide security money of Rs. One lakh, per vehicle, in form of discharged FDR in favour of Prathama U.P. Gramin Bank. The same will remain under custody of the Bank till the expiry of contract.
- 8. The tender requirement is for operating 05 (Five) customized Demonstration Vans 'on monthly basis, which includes details of operating cost (fuel, incidental, parking) timely service and maintenance cost and driver charges, including fuel cost of generator to be used only for running the gadgets provided in the Van, etc.'
- 9. The service provider shall provide unhindered services of 1 driver (valid driving license holder) cum caretaker per vehicle. In case of leave (or absence for any reason) of regular Driver, alternative arangements will be provided by the service provider. Also, as fuel charges are directly related to running kilometers of van, it would be logical to fix minimum kilometers (say 1000 km) per month to enable vandors to do their costing on fuel. For any excess running beyond 1000 kms. If any, fuel charges/rates may be quoted per kilometers to meet the cost of fuel.
- 10. Bank reserves the right to further negotiable the prices quoted by final bidder, if deemed that rates mentioned are not justified as per present market scenario.
